

B4SA: Weekly Update 12 June 2021

You will undoubtedly have followed developments over the past few days related to the South African COVID-19 vaccine acquisition and rollout programme. Colleagues will be aware that we established the B4SA vaccine platform to provide up-to-date information on bilateral and multilateral engagements with government, hopefully enabling businesses to respond to the latest news.

Dear B4SA and business colleagues,

The country is now experiencing a third wave of the pandemic. We need to get everyone—whether living in well-serviced cities or in less well-connected rural and peri-urban areas—to register on the Electronic Vaccination Data System (EVDS) if they are 60 years and above.

B4SA thanks South African businesses for its response in helping to reach the almost three million citizens—of a potential 5.5 million—over 60s who have not yet registered for their COVID-19 vaccination on the EVDS. Many older people don't have reliable internet access or smartphones, while others may not trust or are uncertain of how to use a new system. It is interesting to note that current registration statistics show higher uptake in rural areas, as compared to urban settings.

We are grateful especially for the following initiatives:

Big retailers are helping to register those over-60s collecting their pensions at stores dispensing high volumes of social grants.

FNB will support customers over 60 to register at 600 branches.

South African Breweries launched an advertising campaign that encourages over-60s to register.

The Phase 2 vaccination rollout continues. As of 10 June, 1,619,011 vaccines had been administered. More vaccination sites are coming online in the private and public sectors. More sites will be brought online as we receive larger volumes of vaccines.

There has been no final indication when the two million J&J doses held in the Gqeberha facility will be released. On Friday night, the Department of Health announced that SAHPRA and SAHPRA will advise if they are suitable for use in South Africa. They department also announced that 300 000 doses of J&J were cleared to be shipped to South Africa as a matter



of extreme urgency. We are still, therefore, in a vaccine-constrained environment. Pfizer continues to supply 636,000 vaccines per week.

The number of vaccines administered daily is climbing. As of midnight on 9 June, we are now looking at roughly 85,245 per day. We still have a long way to go.

Keeping up the momentum on the vaccination programme is essential. Still, we cannot forget to do the basics, especially since we are officially in the third wave: wear your masks, wash or sanitise your hands regularly, and maintain social distancing. This also means avoiding large indoor gatherings.

B4SA met with the acting Health Minister—Tourism Minister Mmamoloko Kubayi-Ngubane—and reconfirmed its commitment to supporting the NDOH on the vaccination rollout.

We continue to ask for your support and co-operation. Everyone needs to get registered on the government EVDS platform, help others register, and get vaccinated when directed to do so. Here is the link to register—here is the link.

Stay safe—register if you are over 60, and tell and help others do the same.

STOCK VISIBILITY SYSTEM (EVS) AND ELECTRONIC VACCINATION DATA SYSTEM (EVDS)

All public and private vaccination sites must implement the guidance and practice set out in the attached letters by the Director General of Health, Dr Sandile Buthelezi on the correct use of the EVDS and EVS system.

RE: IMPROVED USE OF THE STOCK VISIBILITY SYSTEM AND ELECTRONIC VACCINATION DATA SYSTEM FOR THE MONITORING AND ACCOUNTABILITY OF COVID-19 VACCINE AND ANCILLARY ITEM STOCK LEVELS



The letter dated 16 April 2021 regarding the use of the Stock Visibility System (SVS) for monitoring COVID-19 vaccine and ancillary items refers (See attached). The Department, through the Affordable Medicine Directorate (AMD), has implemented SVS to enable rapid and timeous access to vaccine and ancillary item availability data during the roll-out of the COVID-19 vaccination programme.

To date, over 1,300 sites have been registered on the SVS COVID-19 vaccine instance across all provinces and are submitting data that is being used by planners involved in the supply and logistics value chain. Unfortunately, the reporting on the system at present is not in accordance with the stipulated reporting requirements. Additionally, the quality of the data being submitted suggests that end users have not adequately engaged with and understood the materials that have been shared to guide optimal use of the system.

The on-site electronic vaccination data system (EVDS) was developed and deployed as the central system for recording all COVID 19 Vaccinations. The system is the authoritative source of all COVID-19 Vaccinations in the country. This is essential to uniquely identify everyone who has received a vaccine to ensure they can be allocated a second dose (dependant on vaccine regime), support pharmacovigilance, input into the no fault compensation and medicolegal processes and protection against fraud and corruption.

The data from the SVS and the EVDS is reconciled to determine trends on the possible loss and wastage of vaccines. This is an important process to allow for accountability on the use of the vaccines.

USE OF THE STOCK VISIBILITY SYSTEM FOR THE MONITORING COVID-19 VACCINE AND ANCILLARY ITEM STOCK LEVELS

While it is understood that there will be initial challenges in uptake when rolling out new systems, it is also understood that there will be a need for interventions to be made through your office to ensure these initial challenges are overcome and address to improve the Utilization of the on-site EVDS as well as the reporting frequency and data quality of the SVS. The AMD and EVDS Teams will be engaging with your elected points of contact to indicate challenges specific to your facilities and provide suggested remedial actions to resolve these.

The significance of this data to support effective planning and ensure equitable access to and distribution of the limited vaccine and ancillary stock cannot be overstated. To ensure optimal efficiency and rapid turnaround time in the planning process, all sites participating in the COVID-19 vaccine roll-out as vaccination and/or distribution sites where vaccine stock is stored, in both the public and private sector, are requested to submit vaccine and ancillary availability data on SVS in accordance with the set-out reporting requirements.

All vaccination sites are required as per the policy decision to use the EVDS to record vaccinations directly online. The use of manual forms should be limited to exceptional



cases e.g. power outage. In such cases, the manual forms should be back captured on the EVDS within 24 hours.

Failure to meet the SVS reporting requirements and recording of vaccinations on the EVDS will result in sites being flagged as non-compliant, and any non-compliant sites may therefore not be eligible to receive further stock replenishments for the COVID-19 vaccines.

Guidance to all private sector vaccination sites

We have noted that a number of vaccination sites are using the incorrect web address for the Master Facility List (MFL) portal.

Please be advised that the correct web address is:

https://mfl.csir.co.za

Official NDOH guidance requires sites to provide vaccinees with at least 72 hours' notice between receiving an SMS and presenting themselves to a vaccination site.



We recommend that all sites **revise their schedules to seven days** forward to allow vaccinees sufficient time to plan for their appointments and assist in the advance allocation of stock.

Your Guide to the Electronic Vaccination Data System (EVDS)

6 steps to register for vaccination if you are 60 years or older:





Make sure you have internet access

STEP 2



You will need a smartphone, a tablet or a computer

STEP 3



Connect to the internet and go to

https://vaccine.enroll.health.gov.za/f/

STEP 4



The welcome screen will tell you what to do next.

STEP 5



Follow the instructions Put in all the details the system asks for

STEP 6



When you are done the system will send an SMS to the phone number you provided This SMS will tell you that you are registered. This means that the system now has you in the queue.

When it is your turn to be vaccinated, the system will send you another SMS with a date and the venue for your vaccination.

If you put in the correct address, you will be sent to the vaccination centre that is closest to your home
